- Sealed or electronic bids must be submitted to the office Thalara Rural Municipality, Bajhang through PPMO website www.bolpatra.gov.np/egp on or before 12:00 on 2079/05/31 (16th September, 2023). Bids received after this deadline will 5. be rejected.
- The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 noon on 2079/05/31 (16th September, 2023) at the office of Thalara Rural Municipality, Bajhang. Bids must be valid for a period of 90 days 6. after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format amounting as below, which shall be valid for 30 days beyond the validity period of the bid.
