1. Office of Thalara Rural Municipality, Kholi, Bajhang invites electronic bids from Nepalese eligible bidders for the construction of RCC Canals under National Competitive Bidding procedures.

Bidders, submitting their bid electronically, should deposit the cost of NRs 3000/- (Three Thousands only) of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 4. Pre-bid meeting shall be held at Office of Thalara Rural Municipality, Bajhang at 14:00 noon on 2079/10/11 (25<sup>th</sup> January, 2023).
5. Sealed or electronic bids must be submitted to the office Thalara Rural Municipality, Bajhang through PPMO website [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before 12:00 on 2079/10/20 (3<sup>rd</sup> February, 2023). Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 noon on 2079/10/20 (3<sup>rd</sup> February, 2023) at the office of Thalara Rural Municipality, Bajhang. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format amounting as below, which shall be valid for 30 days beyond the validity period of the bid.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
