Invitation for Bids for the **Construction of Thalara Rural Municipality Building**

1. Thalara Rural Municipality invites electronic bids from eligible bidders for the Construction of Thalara Rural Municipality Building under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **Rs 25343227.42**
 - Minimum Work experience of similar size and nature: **Rs 19193270.90**
2. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

5. Pre-bid meeting shall be held at **Thalara Rural Municipality Office** at **[2077/10/09[Jan 22, 2021]]** at 13:00 noon.
6. Sealed or electronic bids must be submitted to the office **Thalara Rural Municipality Office, Kholi, Bajhang** through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12:00 noon** on **2077/10/20 [Feb 02, 2021]**. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **14:00 noon** on **2077/10/20 [Feb 02, 2021]** at the office of **Thalara Rural Municipality**. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format amounting to a minimum of **Rs 677600**, which shall be valid for 30 days beyond the validity period of the bid.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
