Electronic bids must be submitted to the office of *Thalara Rural Municipality Office, Kholi, Bajhang* through PPMO website <a href="www.bolpatra.gov.np/egp">www.bolpatra.gov.np/egp</a> on or before *12:00 noon* on *2077/10/20 [Feb 02, 2021]*. Bids received after this deadline will be rejected.
- 6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 noon on 2077/10/20 [Feb 02, 2021] at the office of Thalara Rural Municipality. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format amounting to a minimum of Rs 193200, which shall be valid for 30 days beyond the validity period of the bid.
- 7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
