A complete set of Bidding Documents may be purchased from the office of Thalara Rural Municipality, Kholi, Bajhang by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of NRs. 1000.00 till 2077/10 /04 [Jan 17,2021] during office hours.
- 4. Sealed bids must be submitted to the office of Thalara Rural Municipality, Kholi, Bajhang by hand on or before 12:00 noon on 2077/10/05 [Jan 18, 2021]. Bids received after this deadline will be rejected.
- 5. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 noon on 2077/10/05 [Jan 18, 2021] at the office of Thalara Rural Municipality, Kholi, Bajhang. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of 33,750 which shall be valid for 30 days beyond the validity period of the bid. If bidder wishes to submit the Cash Security, the cash should be deposited in Deposit Account Name: "THALARA GA.PA. ISTHANIYA TAHA DHARAUTI KHATA GA 3" Account No. 1840102612300016 at Kumari Bank and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
